BY ORDER OF THE GOVERNMENT OF THE HELLENIC REPUBLIC ALL NON EU CITIZENS ARE PROHIBITED TO ENTER THE HELLENIC REPUBLIC.
EXCEMPTED FROM THE RESTRICTION ARE:

1. FAMILY MEMBERS OF EU CITIZENS.
2. CITIZENS OF SCHENGEN MEMBER STATES AND THEIR FAMILY MEMBERS.
3. HEALTHCARE PROFESSIONALS AND HEALTH RESEARCHERS DESIGNATED TO SUPPORT THE HELLENIC NATIONAL HEALTHCARE SYSTEM.
4. THIRD-COUNTRY CITIZENS WHO ARE LONG-TERM RESIDENTS OR LONG TERM VISA HOLDERS OF AN EU OR SCHENGEN MEMBER STATE.
5. THIRD COUNTRY GOVERNMENT MEMBERS, DIPLOMATS, STAFF OF INTERNATIONAL ORGANISATIONS, MILITARY PERSONNEL AND HUMANITARIAN AID WORKERS IN THE EXERCISE OF THEIR DUTIES.
6. PASSENGERS IN TRANSIT.
7. AIRCRAFT FLIGHT CREW.
8. NON EU OR NON SCHENGEN CITIZENS TRAVELLING FOR IMPERATIVE FAMILY OR BUSINESS REASONS PROVIDED THAT THE RELEVANT AUTHORIZATION HAS BEEN OBTAINED BY THE HELLENIC CONSULATE.

- EXEMPTED FROM THE RESTRICTION ARE:

1. FLIGHTS APPROVED BY THE HELLENIC MINISTRY OF FOREIGN AFFAIRS FOR REPATRIATION OF GREEK CITIZENS, THEIR FAMILY MEMBERS AND HOLDERS OF RESIDENCE PERMIT IN GREECE.

BY ORDER OF THE GOVERNMENT OF THE HELLENIC REPUBLIC, ALL COMMERCIAL FLIGHTS AND GA/BA, FROM/TO ANY AERODROME IN THE TERRITORY OF ALBANIA, ITALY, NETHERLANDS, NORTHERN MACEDONIA, SPAIN AND UNITED KINGDOM TO ANY AERODROME IN THE HELLENIC REPUBLIC ARE SUSPENDED. ALL COMMERCIAL FLIGHTS AND GA/BA, FROM/TO ANY AERODROME IN THE TERRITORY OF THE STATE OF GERMANY AND ALL OTHER COUNTRIES ARE PERMITTED ONLY TO ATHENS INTERNATIONAL AIRPORT LGAV. FLIGHTS TO ALL OTHER AERODROMES IN THE HELLENIC REPUBLIC ARE SUSPENDED.

ALL PASSENGERS MUST COMPLETE THE PROVIDED HEALTH FORM OF CIVIL PROTECTION.

*+ COVID-19 PASSENGER RESTRICTIONS.

BY ORDER OF THE GOVERNMENT OF THE HELLENIC REPUBLIC, RESTRICTIONS UPON ENTRY INTO THE HELLENIC REPUBLIC TO ANY INDIVIDUAL-REGARDLESS OF NATIONALITY-WILL APPLY AS FOLLOWS:

-PASSENGERS ARE REQUIRED TO REMAIN IN ISOLATION UNDER QUARANTINE FOR 14 DAYS UPON ARRIVAL, WITH NOTIFICATION OF CONTACT INFORMATION TO THE APPROPRIATE AUTHORITIES AT THE AIRPORT OF ARRIVAL.

-NO ENTRY TO THE HELLENIC REPUBLIC WILL BE PERMITTED TO PASSENGERS NOT ACCEPTING THE AFOREMENTIONED REQUIREMENTS.

-EXEMPTED FROM THE RESTRICTION ARE:

1. PASSENGERS IN TRANSIT.
2. ALL AIRCRAFT FLIGHT CREW
3. PERSONS ON BOARD OF THE FOLLOWING FLIGHTS:
 - STATE FLIGHTS
 - SANITARY FLIGHTS
 - HUMANITARIAN FLIGHTS
 - EMERGENCY FLIGHTS
 - MILITARY FLIGHTS
 - CARGO FLIGHTS
 - FRONTTEX FLIGHTS
