- + ORDER OF THE CHIEF SANITARY INSPECTOR TO PREVENT THE SPREAD OR INTRODUCTION OF INFECTION CAUSED BY SARS-COV-2.
APPLIES TO ALL INTERNATIONAL FLIGHTS TO THE REPUBLIC OF POLAND AND TRANSITS.
COVID-19: REQUIREMENTS FOR ACFT CREW
- I.
THE ACFT CREW IS OBLIGED TO FILL IN THE HEALTH-RELATED PART OF THE GENERAL DECLARATION AND TO SUBMIT IT TO APPROPRIATE AUTHORITIES AFTER LANDING ON THE FIRST AIRPORT ON THE TERRITORY OF THE REPUBLIC OF POLAND.
- II.
THE ACFT CREW MEASURES THE TEMPERATURE OF ALL PASSENGERS, DISTRIBUTES THE PASSENGER LOCATOR FORMS FOR HEALTH PURPOSES (APPENDIX 13 TO ICAO ANNEX 9) AMONG ALL PASSENGERS ON BOARD OF THE ACFT AND INFORMS THE PASSENGERS ON THE NECESSITY TO FILL THEM IN, FURTHER THE CREW COLLECTS THE FILLED IN FORMS AND SUBMITS THEM TO THE APPOINTED GROUND SERVICES ON THE FIRST AIRPORT ON THE TERRITORY OF THE REPUBLIC OF POLAND.
- III.
IF THE ACFT CREW DOES NOT PERFORM THE ACTIVITIES MENTIONED IN POINT II ABOVE, IT SUBMITS TO THE APPOINTED GROUND SERVICES INFORMATION ON THE NECESSITY TO PERFORM THEM ON BOARD OF THE ACFT ON THE FIRST AIRPORT ON THE TERRITORY OF THE REPUBLIC OF POLAND.

- + COVID-19: RESTRICTIONS
- I.
THE COUNCIL OF MINISTERS OF THE REPUBLIC OF POLAND ISSUED A REGULATION FOR THE PROTECTION OF PUBLIC HEALTH AND THE LIMITATION OF THE COVID-19 SPREAD (SARS-COV-2) WHICH INTRODUCES BANS IN AIR TRAFFIC.
- II.
THE REPUBLIC OF POLAND RESTORED BORDER CONTROL AT THE NIGHT OF MARCH 13/14 2020.
- III.
COVID-19: INTERNATIONAL FLT RESTRICTIONS
TILL MAY 23, 2020, AT 2359LMT (MAY 23, 2020, AT 2159UTC) CIVIL

AIRCRAFT PERFORMING INTERNATIONAL FLIGHTS WITH PASSENGERS LANDING ON REGISTERED CIVIL AIRPORTS AND ON REGISTERED AIRSTRIPS WITHIN THE REPUBLIC OF POLAND ARE BANNED.

ENR ATS IS NORMAL BUT AIR OPERATORS WHOSE AIRCRAFT PERFORM TRANSIT FLIGHTS THROUGH THE EPWW FIR, SHOULD NOT PLAN ALTERNATE AIRPORTS ON THE TERRITORY OF THE REPUBLIC OF POLAND.

FOLLOWING FLIGHT OPERATIONS ARE EXEMPTED FROM ABOVE:

- 1) CARGO FLIGHTS, FLIGHTS WITHOUT CARGO AND WITHOUT PASSENGERS,
- 2) FLIGHTS WITH STATUS: HOSP, HUM, HEAD AND OTHER FLIGHTS PERFORMED IN ORDER TO SAVE PEOPLE'S LIVES OR HEALTH (E.G. WITH THE RESCUE PAROLE), FLIGHTS TO PROTECT PUBLIC ORDER (E.G. WITH THE GUARD PAROLE),
- 3) FLIGHTS TO THE REPUBLIC OF POLAND BY AIRCRAFT CHARTERED AT THE ORDER OF:
 - TOUR OPERATORS OR AN ENTITY ACTING ON THEIR BEHALF BEFORE MARCH 15, 2020
 - THE PRIME MINISTER
 - A NATURAL OR LEGAL PERSON, PERFORMED BY AIRCRAFT WITH UP TO 15 PASSENGER SEATS.
- 4) CHARTER FLIGHTS PERFORMED BY FOREIGN AIR CARRIERS AT THE ORDER OF FOREIGN STATES IN ORDER TO BRING BACK THEIR CITIZENS,
- 5) EMERGENCY FLIGHTS.

IV.

COVID-19: NATIONAL FLIGHT RESTRICTION

TILL MAY 23, 2020 AT 2359LMT (MAY 23, 2020 AT 2159UTC) COMMERCIAL NATIONAL FLIGHTS WITH PASSENGERS ARE BANNED.

THE FOLLOWING FLIGHT OPERATIONS ARE EXEMPTED FROM ABOVE:

1. FLIGHTS PERFORMED BY PUBLIC OR STATE INTEREST
2. FLIGHTS PERFORMED BY AIRCRAFT WITH UP TO 15 PASSENGER SEATS PERFORMING COMMERCIAL LANDING IN ORDER TO EMBARK OR DISEMBARK PASSENGERS.

V.

COVID-19: PASSENGERS RESTRICTIONS

THE FOLLOWING PASSENGERS ARE ALLOWED TO ENTER THE REPUBLIC OF POLAND:

- 1) CITIZENS OF THE REPUBLIC OF POLAND,
- 2) FOREIGNERS WHO ARE SPOUSES OR CHILDREN OF CITIZENS OF THE REPUBLIC OF POLAND OR WHO ARE UNDER PERMANENT CUSTODY OF CITIZENS OF THE REPUBLIC OF POLAND,
- 3) FOREIGNERS HAVING A POLE'S CARD,
- 4) HEADS OF DIPLOMATIC MISSIONS AND MEMBERS OF THE DIPLOMATIC AND CONSULAR PERSONNEL OF A MISSION, I.E. PERSONS WITH A DIPLOMATIC RANK AND MEMBERS OF THEIR FAMILIES,
- 5) FOREIGNERS WITH A PERMANENT OR TEMPORARY RESIDENCE PERMIT ON THE TERRITORY OF THE REPUBLIC OF POLAND,
- 6) FOREIGNERS WITH A RIGHT TO BE EMPLOYED ON THE TERRITORY OF THE REPUBLIC OF POLAND, I.E. FOREIGNERS WITH A RIGHT TO PERFORM WORK ON THE SAME RULES AS CITIZENS OF THE REPUBLIC OF POLAND, HAVING AN EMPLOYMENT PERMIT, A SEASONAL EMPLOYMENT PERMIT, A STATEMENT ON ENTRUSTMENT OF WORK TO A FOREIGNER ON THE TERRITORY OF THE REPUBLIC OF POLAND,
- 7) FOREIGNERS WHO GAINED A PERMIT OF THE COMMANDER OF A BORDER GUARD UNIT TO ENTER THE TERRITORY OF THE REPUBLIC OF POLAND.

VI.

BEFORE THE TAKE-OFF, AIR OPERATORS ARE OBLIGED TO INFORM THE PASSENGERS WHO FLY TO THE REPUBLIC OF POLAND ABOUT THE CONTENT OF POINT V ABOVE.
