ANY AIRCRAFT THAT DUE TO TECHNICAL FAILURES OR UNEXPECTED EVENTS REQUEST TO LAND AT THE MPTO OR MPPA AIRPORT WILL BE CONSIDERED AN EMERGENCY AND WILL BE TREATED

ACCORDING TO THE LOCAL HEALTH REGULATIONS.
