### **BUSINESS FLIGHT RESTRICTIONS**

- Cargo, Tech stop, Humanitarian, UN, Repatriation and Medevac flights
- International passenger flights suspended (Domestic passenger flight allowed subject to a negative PCR test result no older than 72HRS before boarding)

### **RESTRICTIONS FOR TECHNICAL REFUELING/CREW REST**

- Only Cargo flights are allowed and Crew may not disembark the aircraft and operator must ensure they have sufficient crew/time for the return flight
- Crew rest Not Allowed

### **QUARANTINE REQUIREMENTS**

- 14 day Quarantine for returning Malagasy Nationals

### **DATE THE RESTRICTION IS CURRENTLY EXPECTED TO END OR BE RE-EVALUATED**

- January 16, 2021
