

CERTIFICATE OF TRAVEL RESTRICTION WAIVER

For persons residing in departments subject to reinforced measures

BETWEEN 6 am and 7 pm

Pursuant to Article 4 of Decree No. 2020-1310 of 29 October 2020 laying down general requirements to respond to the COVID-19 pandemic during the current state of public health emergency

Travel is permitted subject to evidence of one of the reasons set out in this certificate being provided.

Within a 10-km radius around the place of residence, travel is permitted without a certificate provided proof of residence can be presented.

Travel outside the boundaries of the department of residence is only possible for the compelling reasons stated in points 6 to 12 of this certificate.

These reasons also permit persons residing outside departments subject to reinforced measures to travel to the departments covered by these measures.

Hereby certify that my travel is for the following reason (tick the box) authorized under the general requirements to respond to the COVID-19 pandemic during the current state of public health emergency:¹

Travel within a radius of 10 kilometres from the home

1. Physical exercise and walking

Travel connected either to walking or to the individual physical exercise of persons.

[Certificate to be completed only is proof of residence cannot be presented]

Travel within the department of residence ²

2. Shopping

Travel to make purchases of basic necessities, or to pick up ordered goods

3. Accompaniment of children to school

Travel to take/collect children to/from school and in connection with their out-of-school activities

4. A cultural establishment or a place of worship

Travel to visit a cultural establishment (libraries and media libraries) or a place of worship

¹ Persons seeking to qualify for one of these exemptions must, if required, carry a document with them when travelling away from home to prove that their travel falls within the scope of one of such exemptions.

² For persons resident close to the boundary of a department, a tolerance of 30 kilometres beyond the department is accepted.

5. Administrative or legal formalities

Travel to a public service for formalities or proceedings that cannot be conducted remotely

Travel with no restriction on distance:

6. Professional occupation, education and training, general interest mission

Travel between the home and the place of work, education or training, business travel that cannot be postponed, home deliveries, travel to make purchases of supplies required for the professional occupation, travel connected to general interest missions at the request of the administrative authority

7. Health (consultations and care/treatment)

Travel for consultations, examinations/check-ups, preventive procedures (including vaccination) and care/treatment that cannot be provided remotely, or to buy health products.

8. Compelling family reason, vulnerable or needy persons, or childcare

Travel for compelling family reasons, for assistance to vulnerable or needy persons, or for childcare.

9. Disability

Travel of people with disabilities and their carers

10. Judicial or administrative summons

Travel to respond to a judicial or administrative summons, travel to a legal professional for formalities or proceedings that cannot be conducted remotely

11. Moving home

Travel connected to moving home due to a change of residence and travel which is essential for the purchase or rental of a main residence that cannot be postponed

12. Transit travel to stations and airports
