OPEN WITH RESTRICTIONS
US aircraft: Allowed to enter

US passenger: Allowed to enter with a vaccination certificate.

Quarantine: Exempted with a PCR 72h / vaccination certificate / recovery certificate

BUSINESS FLIGHT RESTRICTIONS

Flights from any airports from BRAZIL and SOUTH AFRICA to any airports in Spain are allowed ONLY in the following cases:

- Aircraft carrying exclusively Spanish/Andorran citizens or residents
- Aircraft carrying exclusively passengers in transit with final destination in a non-Schengen country with a stopover of less than 24 hours and without leaving the airport transit zone
- State aircraft
- Search and Rescue services
- Technical stops (no disembark) with final destination in another country
- Cargo, ferry, humanitarian, medical or emergency flights

Exempted from the above are:

- Flight personnel necessary to carry out air transport activities.
- Special flights for justified reasons with a special authorization from the Spanish Ministry of Health.

Third Country nationals are allowed to enter Spain ONLY when traveling under the following travel categories:

- Spanish citizens and permanent residents.
- Citizens, permanent residents or long-term visa holders of EU/Schengen member states on their way to such country; proof is required
- Healthcare professionals
- Transport personnel
- Staff of diplomatic missions or international organizations exercising their duties
- Students pursuing their studies in the EU/Schengen countries



- Highly qualified workers whose labour is necessary; justification is required
- People traveling for duly accredited imperative family reasons
- People with documented force majeur reasons
- Legal residents in the following countries: AUSTRALIA, ISRAEL, JAPAN, NEW ZEALAND, RWANDA, SINGAPORE, SOUTH KOREA, THAILAND, UNITED. CHINA AND SPECIAL ADMINISTRATIVE REGIONS OF HONG KONG AND MACAO on reciprocity principle. Valid for direct arrivals from these countries or when airport transit carried out in the countries not listed.
- Holders of a vaccination certificate recognized by the Spanish Ministry of Health and accompanying minors.

RESTRICTIONS FOR TECHNICAL REFUELING/CREW REST

- Technical refueling is allowed
- Crew rest is allowed

QUARANTINE REQUIREMENTS

From June 7, all passengers arriving from risk areas are required to present a **negative covid-19 test result** not older than **72 hours** prior arrival or a **vaccination certificate** or a **certificate of recovery**.

- Spain accepts the following test types: PCR, TMA and RT-LAMP.
- Vaccination certificate must state the traveler has completed the full vaccinations at least 14 days prior the flight (valid up to one year after the date of vaccination).
- Recovery certificate corresponds to a test no more than 90 days after the date of the
 first positive NAAT test result, no earlier than the 11th day following the date of that
 positive test result, and 3 months after serological test result.

From June 7, **Third Country nationals** incl. US passengers are allowed to enter with a **vaccination certificate.**

Crew exercising their duties is exempted from the PCR test requirements.

Passengers whose origin of travel is INDIA must remain in quarantine for 10 days after arrival. Quarantine period can be shortened with a negative follow up test taken not earlier than on the 7th day after arrival.

Travelers are recommended to stay aware of the local restrictions as changes can occur on a short notice.

DATE THE RESTRICTION IS CURRENTLY EXPECTED TO END OR BE RE-EVALUATED

ADDITIONAL INFORMATION

- All arriving passengers are required to complete an electronic Public Health Locator form online prior traveling and present the received QR code upon entry. Electronic form is available at: https://www.spth.gob.es/
- All passengers arriving by air or sea must undergo a temperature check, which must be below 37.5 degrees Celsius. Shipping companies can take passengers' temperature before arriving at a Spanish port.
- Any passengers who are suspected of carrying COVID-19 or another contagious disease
 will be subjected to another health assessment, which will include taking their
 temperature again and evaluating their clinical and epidemiological health. If an
 infectious disease is confirmed, the traveller will be taken to a medical centre.
- Use of masks is mandatory for all users of air transport.

COVID-19: CREWS/PASSENGERS REQUIREMENTS

IN ACCORDANCE WITH DIRECTORATE-GENERAL FOR PUBLIC HEALTH RESOLUTION OF 11 NOVEMBER AND 9 DECEMBER 2020:



- -SANITARY CONTROLS ARE CARRIED OUT TO PASSENGERS ARRIVING BY AIR IN SPAIN BEFORE ENTERING THE COUNTRY, WHICH MAY INCLUDE A TEMPERATURE CHECK, A DOCUMENTARY CONTROL AND A VISUAL HEALTH ASSESSMENT. INTERNATIONAL PASSENGERS IN TRANSIT WITH FINAL DESTINATION IN ANOTHER COUNTRY ARE EXCLUDED.
- -REGARDING THE DOCUMENTARY CONTROL, ALL PASSENGERS DEPARTING FROM ANY AIRPORT LOCATED OUTSIDE SPANISH TERRITORY MUST FILL OUT A HEALTH CONTROL FORM PRIOR TO TRAVEL, THROUGH THE INTERNET SITE 'WWW.SPTH.GOB.ES' OR VIA THE FREE APP 'SPAIN TRAVEL HEALTH-SPTH'. ONCE THE FORM IS COMPLETED, EACH PASSENGER WILL OBTAIN A QR CODE ASSOCIATED TO THE TRIP, WICH MUST BE SUBMITTED UPON ARRIVAL IN SPAIN. EXCEPTIONALLY, PASSENGERS UNABLE TO COMPLETE THE HEALTH CONTROL FORM ELECTRONICALLY, MAY SUBMIT IT IN PAPER FORMAT (DIN A4 SIZE, DOUBLE-SIDED) UPON ARRIVAL IN SPAIN.
- -PASSENGERS ARRIVING TO SPAIN FROM A HIGH-RISK COUNTRY/AREA MUST PROVIDE EVIDENCE OF A NEGATIVE SARS-COV-2 TEST (COVID-19 RT-PCR, TMA OR ANY OTHER TEST TYPE BASED ON EQUIVALENT MOLECULAR TECHNIQUES) RESULT, TAKEN WITHIN 72 HOURS PRIOR TO ARRIVAL. CHILDREN UNDER THE AGE OF SIX AND FLIGHT CREWS TRAVELLING ON DUTY ARE EXCLUDED. THE ORIGINAL CERTIFICATE OR SUPPORTING DOCUMENT MAY BE REQUESTED AS PART OF THE DOCUMENTARY CONTROL. IT MUST BE WRITTEN IN SPANISH, ENGLISH, FRENCH OR GERMAN (OTHERWISE, IT MUST BE ACCOMPANIED BY A TRANSLATION INTO SPANISH CARRIED OUT BY AN OFFICIAL BODY) AND MAY BE PRESENTED EITHER IN PAPER OR ELECTRONIC FORMAT.
- -THE HIGH-RISK COUNTRIES/AREAS LIST CAN BE FOUND ON:
 'HTTPS://WWW.MSCBS.GOB.ES/' AND 'HTTPS://WWW.SPTH.GOB.ES'.
 THE LIST WILL BE REVIEWED EVERY FIFTEEN DAYS (UPDATES BECOME EFFECTIVE SEVEN DAYS AFTER PUBLICATION ON THE ABOVE-MENTIONED WEBSITES).

TRAVEL AGENCIES/TOUR OPERATORS/AIRLINES SHALL INFORM PASSENGERS ABOUT THESE ENTRY REQUIREMENTS DURING THE TICKET SALES AND CHECK-IN PROCESSES.

AIRLINES MUST ALSO CHECK BEFORE BOARDING THAT PASSENGERS TRAVELLING TO SPAIN HAVE THE QR CODE GENERATED THROUGH THE INTERNET SITE 'WWW.SPTH.GOB.ES' OR VIA THE APP 'SPAIN TRAVEL HEALTH-SPTH', AS WELL AS THE DOCUMENT PROVING THE NEGATIVE DIAGNOSTIC TEST RESULT (IF COMING FROM A HIGH-RISK COUNTRY/AREA).

COVID-19: CREWS/PASSSENGERS REQUIREMENTS:

LAW 2/2021, OF 29 MARCH, ON URGENT PREVENTION, CONTAINMENT AND COORDINATION MEASURES TO DEAL WITH THE HEALTH CRISIS CAUSED BY COVID-19, ESTABLISHES THE MANDATORY USE OF MASKS FOR AIR TRANSPORT PASSENGERS (AGED SIX YEARS AND OVER)AND CREWS.

THIS OBLIGATION WILL NOT BE REQUIRED FOR PEOPLE WHO PRESENT SOME TYPE OF ILLNESS OR RESPIRATORY DIFFICULTY THAT MAY BE AGGRAVATED BY THE USE OF THE MASK OR WHO, DUE TO THEIR SITUATION OF DISABILITY OR DEPENDENCE, DO NOT HAVE THE AUTONOMY TO REMOVE THEIR MASK, OR PRESENT BEHAVIOURAL ALTERATIONS THAT MAKE ITS USE UNFEASIBLE.

THIS APPROVAL SHALL BE REQUESTED VIA THE FOLLOWING EMAIL ADDRESS: LOGVAC(AT)AEMPS.ES. AIRCRAFT OPERATORS CARRYING COVID 19 VACCINES REGULARLY MAY REQUEST APPROVAL IN ADVANCE FOR ALL FLIGHTS INVOLVED.

UPON APPROVAL, AIRCRAFT OPERATORS SHALL REQUEST THE ATFM EXEMPTION IN ACCORDANCE WITH THE SPECIFIC PROCEDURE AVAILABLE IN ENAIRE'S ELECTRONIC REGISTER: HTTPS://ENAIRE.SEDE.GOB.ES. STS/ATFMX AND RMK/VACCINE SHALL BE INSERTED IN ITEM 18 OF THE RELATED FLIGHT PLAN

COVID-19: CREWS/PASSSENGERS REQUIREMENTS:

IN ACCORDANCE WITH THE SPANISH GOVERNMENT DECISION, PASSENGERS ARRIVING BY AIR IN SPAIN FROM ANY AIRPORT LOCATED IN THE REPUBLIC OF INDIA (DIRECTLY OR WITH INTERMEDIATE STOPS) SHALL BE QUARANTINED FOR 10 DAYS, OR DURING THE WHOLE STAY IF IT IS LESS THAN 10 DAYS. THE SELF-ISOLATION PERIOD MAY BE REDUCED IF AN ACTIVE INFECTION DIAGNOSTIC TEST IS TAKEN ON THE SEVENTH DAY AFTER ARRIVAL IN SPAIN, WITH A NEGATIVE RESULT.

TRAVEL AGENCIES/TOUR OPERATORS/AIRLINES SHALL INFORM PASSENGERS ABOUT THIS ENTRY REQUIREMENT DURING THE TICKET SALES PROCESS.

FLIGHT PERSONNEL NECESSARY TO CARRY OUT AIR TRANSPORT ACTIVITIES ARE EXEMPTED.

COVID-19: PASSENGER RESTRICTIONS

IN ACCORDANCE WITH MINISTRY OF HOME AFFAIRS ORDER INT/657/2020, THIRD COUNTRY NATIONALS SHALL BE DENIED ENTRY INTO SPAIN FOR REASONS OF PUBLIC ORDER AND PUBLIC HEALTH, UNLESS BELONG TO ONE OF THE FOLLOWING CATEGORIES:

A)REGULAR RESIDENTS IN THE EUROPEAN UNION, SCHENGEN ASSOCIATED STATES, ANDORRA, MONACO, VATICAN (THE HOLY SEE) OR SAN MARINO, ON THEIR WAY TO SUCH COUNTRY, WITH DOCUMENTARY PROOF.
B)HOLDERS OF A LONG-TERM VISA ISSUED BY A MEMBER STATE OR SCHENGEN ASSOCIATED STATE, ON THEIR WAY TO SUCH COUNTRY.
C)HEALTHCARE PROFESSIONALS, INCLUDING HEALTH RESEARCHERS, AND ELDERLY CARE PROFESSIONALS GOING TO OR RETURNING FROM EXERCISING THEIR WORKING ACTIVITY.

D)TRANSPORT PERSONNEL, SAILORS AND THE NECESSARY AERONAUTICAL PERSONNEL TO CARRY OUT AIR TRANSPORT ACTIVITIES.

E)DIPLOMATIC, CONSULAR, INTERNATIONAL ORGANIZATION, MILITARY, CIVIL PROTECTION AND HUMANITARIAN ORGANIZATION PERSONNEL IN THE EXERCISE OF THEIR DUTIES.

F)STUDENTS PURSUING THEIR STUDIES IN THE MEMBER STATES OR SCHENGEN ASSOCIATED STATES, HOLDING THE APPROPRIATE LONG PERMIT OR VISA AND MEDICAL INSURANCE, PROVIDED THAT THEY TRAVEL TO THE COUNTRY IN WHICH THEY ARE STUDYING AND THAT THE ENTRY TAKES PLACE DURING THE ACADEMIC YEAR OR WITHIN THE 15 DAYS PRIOR TO IT. IF THE DESTINATION IS SPAIN AND THE DURATION OF THE STAY IS UP TO 90 DAYS, EVIDENCE MUST BE PROVIDED THAT THE STUDIES ARE CARRIED OUT AT AN APPROVED EDUCATIONAL INSTITUTION, FOLLOWING A FULL-TIME, ON-SITE PROGRAMME, LEADING TO THE AWARD OF A CERTIFICATE/DEGREE.

G)HIGHLY QUALIFIED WORKERS WHOSE LABOUR IS NECESSARY AND CANNOT BE POSTPONED OR CARRIED OUT REMOTELY, INCLUDING PARTICIPANTS IN HIGH-LEVEL SPORTS COMPETITIONS TAKING PLACE IN SPAIN.

THESE CIRCUMSTANCES MUST BE JUSTIFIED BY SUPPORTING DOCUMENTATION. H)PEOPLE TRAVELING FOR DULY ACCREDITED IMPERATIVE FAMILY REASONS.



- I)PEOPLE WHO PROVIDE DOCUMENTARY EVIDENCE OF FORCE MAJEURE REASONS OR IN-NEED SITUATION, OR WHOSE ENTRY IS PERMITTED FOR HUMANITARIAN REASONS.
- J)LEGAL RESIDENTS IN THE FOLLOWING COUNTRIES: AUSTRALIA, ISRAEL, JAPAN, NEW ZEALAND, RWANDA, SINGAPUR, SOUTH KOREA, THAILAND, UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND, CHINA AND SPECIAL ADMINISTRATIVE REGIONS OF HONG KONG AND MACAO, PROVIDED THAT THEY COME DIRECTLY FROM THEM, HAVE TRANSITED EXCLUSIVELY THROUGH OTHER LISTED COUNTRIES OR HAVE ONLY CARRIED OUT INTERNATIONAL AIRPORT TRANSIT IN COUNTRIES NOT LISTED. FOR RESIDENTS IN CHINA AND SPECIAL ADMINISTRATIVE REGIONS OF HONG KONG AND MACAO, RECIPROCITY REMAINS TO BE VERIFIED.
- K) HOLDERS OF A VACCINATION CERTIFICATE RECOGNISED BY THE SPANISH MINISTRY OF HEALTH (SUBJECT TO VERIFICATION BY HEALTH AUTHORITIES) AND ACCOMPANYING MINORS.

EVEN IF BELONGING TO ONE OF THE PREVIOUS CATEGORIES, ANY THIRD-COUNTRY NATIONAL NOT MEETING THE COVID-19 HEALTH CONTROL REQUIREMENTS ESTABLISHED BY THE SPANISH MINISTRY OF HEALTH, SHALL BE DENIED ENTRY INTO SPAIN FOR REASONS OF PUBLIC HEALTH. FOR PERSONS ARRIVING BY AIR IN SPAIN (DIRECTLY OR WITH INTERMEDIATE STOPS) FROM ANY AIRPORT LOCATED IN THIRD COUNTRIES FOR WHICH QUARANTINE REQUIREMENT HAS BEEN ESTABLISHED BY ORDER OF THE SPANISH MINISTRY OF HEALTH, ONLY THE EXEMPTIONS SET OUT IN LETTERS D), E) AND I) SHALL APPLY, EXCEPT FOR RESIDENTS IN SPAIN/ANDORRA OR FAMILY MEMBERS (SPOUSES OF SPANISH CITIZENS OR PARTNER WITH WHOM THEY MAINTAIN A REGISTERED ANALOGOUS CONJUGAL UNION, AND DEPENDENT ASCENDANTS/DESCENDANTS), PROVIDED THAT THEY ARE TRAVELLING WITH OR TO JOIN THEM.

COVID-19: FLIGHT RESTRICTIONS:

IN ACCORDANCE WITH THE SPANISH GOVERNMENT DECISION, FLIGHTS (DIRECT OR WITH INTERMEDIATE STOPS) FROM ANY AIRPORT LOCATED IN BRAZIL/SOUTH AFRICA TO ANY AIRPORT IN THE KINGDOM OF SPAIN, SHALL ONLY BE ALLOWED IN THE FOLLOWING CASES:

- AIRCRAFT CARRYING EXCLUSIVELY SPANISH/ANDORRAN CITIZENS, OR RESIDENTS IN SPAIN/ANDORRA, AS WELL AS PASSENGERS IN TRANSIT WITH FINAL DESTINATION IN A NON-SCHENGEN COUNTRY WITH A STOPOVER OF LESS THAN 24 HOURS, WITHOUT LEAVING THE TRANSIT ZONE OF THE SPANISH AIRPORT.
- STATE AIRCRAFT.
- SEARCH AND RESCUE SERVICES (SAR).
- STOPOVERS FOR NON-COMMERCIAL PURPOSES WITH FINAL DESTINATION IN ANOTHER COUNTRY.
- CARGO, FERRY, HUMANITARIAN, MEDICAL OR EMERGENCY FLIGHTS.

FLIGHT PERSONNEL NECESSARY TO CARRY OUT AIR TRANSPORT ACTIVITIES ARE EXEMPTED FROM THIS RESTRICTION.

FOR JUSTIFIED REASONS, THE SPANISH MINISTRY OF HEALTH MAY LIFT THE RESTRICTION BY AUTHORISING SPECIFIC FLIGHTS.
