Security Information	Nov 8 2018 12:00 UTC		As of May 2012, all outbound passengers and crew will now need to be fully screened and must comply with the same security protocols as commercial passengers. Dublin Airport has built a new facility for screening and an airport charge will apply for screening. Previously, this was not a requirement and passengers and crew were allowed to proceed out to the aircraft without any screening. Business aircraft operators should anticipate that extra time will be needed to clear security.
Security Information	Nov 8 2018 12:00 UTC		<p>Dublin Vendor Alert: Platinum Services offers improved transfer times to aircraft, security screening on departure, and Immigration processing upon arrival</p> <p>With the exception of medical flights will be mandatory for all General Aviation fights to use Platinum Services. This service will provide crew and passengers a significantly improved experience in transfer times to aircraft, security screening on departure and Immigration processing upon arrival. Flights utilizing the Platinum Service Suite will incur a charge for each turnaround.</p> <p>Aircraft less than 8T price €323 + 23% VAT = €397.29  Aircraft greater than 8T to 25T price €645 + 23% VAT = €793.35  Aircraft greater than 25T price €860 + 23% VAT = €1057.80  The rates are exclusive of VAT (23%) and are in addition to your handling fee</p>
Customs Information	Nov 8 2018 12:00 UTC		<p>If pet is arriving from outside of EU Dept.of Agriculture must be contacted in advance of arrival to arrange Vet inspection.</p> <p>Pet Passport must be sent in advance.</p>
Airport Slots	Nov 8 2018 12:00 UTC		<p>In light of the work EUROCONTROL is progressing on its CS (Centralized Services) Projects, CS1 being Flight Plan to Airport Slots Matching, Airport Coordination Limited (ACL) will no longer be issuing airport slot IDs with immediate effect, and as such there is no requirement for an airport slot ID to be added to Field 18 of the FPL.</p> <p>ACL will, as it does now continue to monitor the use of slots at ALL its coordinated airports. Misuse of slots at any of the ACL coordinated airports will continue to be dealt with under the Individual Countries own Aviation Legislation. Within Europe this ultimately remains under Regulation EC 793/2004 Article 14 Enforcement, and Dubai, Dubai Airports Conditions of Use.</p>

<p>Parking Information</p>	<p>Jul 2 2018 12:00 UTC</p>	<p>A parking charge applies from the actual time of arrival (landed time) to the actual time of departure (airborne time) minus 30 minutes as recorded in the Dublin Airport Operations System (AOS) database. All of the parking areas are owned and operated by Dublin Airport Authority. Parking is allocated by the DAA subject to space availability on arrival. Parking rates are determined by the aircraft parking stand rather than the aircraft type. There are (3) types of parking areas allocated to GA aircrafts - an LAP stand, NBR stand or NBC stand.</p> <p>Aircraft Parking: Per 15 minutes or part thereof except for Long Term Remote which is per day or part thereof  LAP Light Aircraft Parking 2.65  NBR Narrow Body Remote 7.7  NBC Narrow Body Contact 27.9</p> <p>Overnight Parking parking from 2300-0600hrs local-time (night-time) is free of charge</p> <p>Dublin discourages long term parking. They do this by adding a surcharge of 100% over 48 hours up to 72 hours and a surcharge of 200% for parking over 72 hours. For example: Parking for nine (9) nights could cost over 15000 Euros. WFS recommends that all customers reposition to another Irish airport, like EINN, if remaining in the country for more than 24 hours.</p>
